Campus Access

Campus Entry: All students will access campus through our gate by the front office (Knox lot) and the gate at the breezeway (Rural lot). Students will need to complete a health survey prior to entering campus. Students can complete the survey two ways:

- a. Students complete an electronic health survey (via the Qualtrics link) sent to student email account. The electronic survey link will be sent daily. - b. Students verbally answer the health questions at our campus entry points

Safety Expectations

Physical Distancing: Students are expected to maintain a physical distance of six feet, whenever feasible. Hallways and classrooms have been marked with tape, guiding signs and reminders to follow physical distancing guidelines.

Masks: Masks are required to be worn by students and staff at all times. Please see the CDC approved masks below.

Recommended



Medical procedure masks (sometimes referred to as surgical masks or disposable face masks)



Masks that fit properly (snugly around the nose and chin with no large gaps around the sides of the face)



Masks made with breathable fabric (such as cotton)



Masks made with tightly woven fabric (i.e., fabrics that do not let light pass through when held up to a light source)



Masks with two or three layers



Masks with inner filter pockets

Not Recommended



Masks that do not fit properly (large gaps, too loose or too tight)



Masks made from materials that are hard to breathe through (such as plastic or leather)



Masks made from fabric that is loosely woven or knitted, such as fabrics that let light pass through



Masks with one layer



Masks with exhalation valves or vents



Wearing a scarf/ski mask

Gaiters & face shields



Wear a gaiter with two layers, or fold it to make two layers



Not recommended: Evaluation of face shields is ongoing, but effectiveness is unknown at this time.

Glasses



If you wear glasses, find a mask that fits closely over your nose or one that has a nose wire to limit fogging.

Lunch:

- Campus will be closed for lunch due to our increased health and safety restrictions. **Students will not be able to go off campus during their lunch period.**
- Free school meals (breakfast & lunch) are available for all students, Monday – Friday, through the end of the year. Students need to present their ID in the cafeteria
- We will not accept any food delivery services to campus (Door Dash, Uber Eats, etc.). Delivery drivers will not be permitted on campus and will be turned away.
- There are a variety of seating areas in the cafeteria, outside, and in the amphitheater for students to eat their lunch and remain socially distanced.

Water Bottles

We encourage students to bring their own water bottles to campus. Water fountains/filling stations are available on campus. We also have vending machines available for students to purchase bottled water.

Technology

- Students are encouraged to bring their district-issued or personal laptops each day to campus to use as a tool in the classroom and to connect with their virtual classmates.
- The Library has a limited number of laptops to loan out; we will check out computers on a daily basis to those students who may need them for class. Students can check out these laptops any time during the day. Loaner laptops may **not** be taken home; students will leave the loaner with their last period teacher.
- The Library staff have set up a charging station for district-issued laptops should a student need to leave their laptop with us to charge during lunch. We do not have charging cords for the variety of personal laptops that students may bring (so students with personal laptops should bring their charging cords if they need to charge during the day).
- The Library staff will be making/distributing IDs for any student who has not yet obtained an official 2020-2021 ID before school, during lunch, and after school until 3:00pm in the library.
- The Library will be closed to general patron traffic after school (with the exception of those students who need to have an ID made).

- Please protect your student's device--whether it is a personal device or a district-issued laptop. Do not put a water bottle (or any liquid) in the backpack with the laptop/device. If your student's backpack does not have a dedicated laptop/computer compartment, consider purchasing a protective sleeve.

Cleaning Procedures

Between class periods: Teachers will be disinfecting desks and materials between each class period.

Bathrooms: Will be routinely disinfected throughout the day.

Hand washing: We encourage students to wash their hands or use hand sanitizer frequently throughout the day

Campus Spaces: Corona del Sol custodial staff will disinfect our student spaces every night.

Student ID's

- Once made, student IDs must be worn on a lanyard and visible at all times while on campus. Students may use the **StudentVue ID** available in the *StudentVue* app as a Temporary ID.
