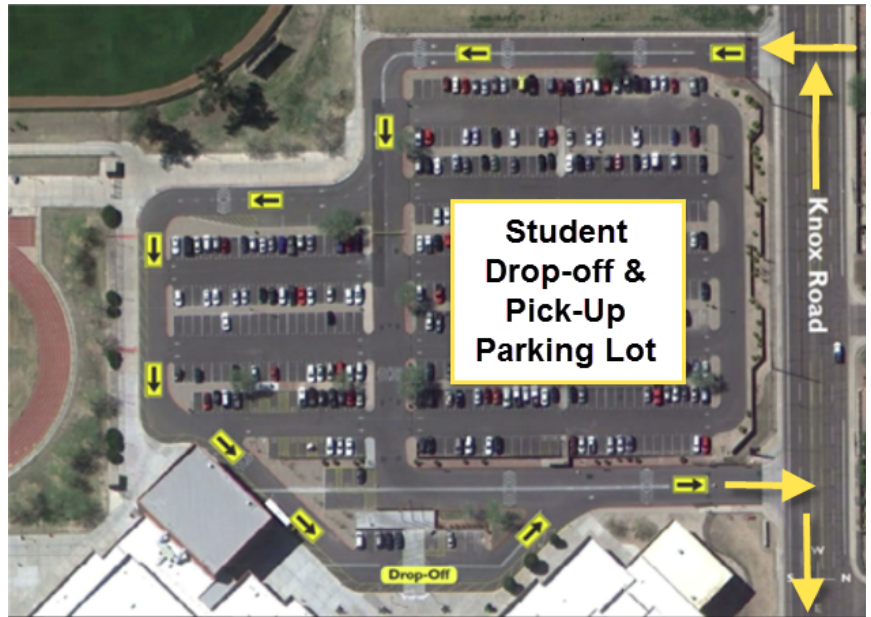
Student Drop-Off & Pick-Up & Parking

Student drop-off/pick-up and student parking are located in the parking lot off of Knox Road.

1. Enter from Knox Road.
2. Follow signs to student drop-off.
3. Exit right from the driveway onto Knox Road only.

Please note: Traffic and parking are typically congested. Please allow adequate time for drop off and pick up. Carpooling is highly recommended. School bus transportation from your home school is available for a fee of \$35.

Do not stop in the street to let out or pick up students. This poses extreme hazards to students. Stopped vehicles will be cited by the Phoenix Police. Violations of F.C 902.2 may receive a fine of \$40.00 per incident.



Summer Education Attendance Policy

Attendance Policy: Summer Education Academy students are allowed no more than two (2) absences in each session. Attendance reporting will begin the first scheduled day of class. Students who enter school late will be considered absent for the days missed and are responsible for making up missed work. **Students will be withdrawn on the third (3rd) absence.** No credits, incompletes or refunds are issued for a student who is withdrawn due to excessive absences.

Tardy Policy: A tardy is defined as being late to class at the beginning of the school day and/or after each break. If students are more than fifteen (15) minutes late (arrive late, leave early, etc.), it will be counted as an absence.

Student Sign-In Policy: If a student arrives after the beginning of the school day (7:30 am, the student must sign in at the Summer Education Academy office and receive a hall pass. Students leaving campus before 12:45 pm will sign out through the Summer Education Academy office. **Please notify the Summer Education Academy office of all late arrivals and early releases.**

Closed Campus Policy: The Summer Education Academy Campus is a "CLOSED CAMPUS". Students must remain on campus during school hours.
