Parking Lot Application (revised 3.6.18)

Parking permits for the *main* DV parking lot are sold on a first-come, first-served basis to LICENSED drivers **only** in the Class of 2019 (seniors) and Class of 2020 (juniors). Parking permits for the *church* parking lot are sold on a first-come, first-served basis to the above classes as well as the Class of 2021 (sophomores) with either an Instructional Permit or Driver's License.

Note: Parking permits are not transferable, nor can they be sold or given as gifts.

Online Registration:

Prior to completing this application, you *must* submit an online parking registration. Go to the Activities tab on our DV website & click on "Student Parking" to access the online parking registration. After completing the online registration, please bring this completed application, along with all required documentation, to the Activities Office before making payment in the bookstore!!

Documentation:

Attach **copies** of the following items to this application: 1) Driver's License (an Instructional Permit is fine for church lot parking), 2) proof of current Vehicle Insurance, and 3) proof of current Vehicle Registration. Applications lacking proper documentation cannot be considered.

Parking Selection: (mark *only* one)

_____ Carpool parking - \$60 (per year) – limited carpool spaces are available. See page 2 for further info.

Student Conduct:

- Our security personnel will enforce parking rules. Violation of the rules, which are enforced for the safety of the drivers and pedestrians, may result in loss of parking privileges.
- Students will not be assigned a specific parking space or row. Parking spaces are available on a first-come, first-served basis. Your parking decal *must* be displayed on driver's side of front window at all times. In the event your decal is moved to a car other than the one you initially registered, all rules and regulations apply to the car displaying the parking permit. The owner of the parking permit will be held responsible and fully liable for any issues that may occur.
- Students may not park in any area marked with a blue curb.
- Students may not be allowed into the parking lot if their parking decal is not properly displayed. Cars not having a properly displayed decal are subject to tow at the owner's expense.
- Students may not go to their cars during the school day without specific permission from administrator or security staff.
- Parking privileges may be lost should a student participate in any of the following activities: reckless driving, transporting alcohol, illegal substances, or weapons; driving in areas marked for pedestrian use only; failure to respond in an appropriate manner to security personnel, intentionally doing damage to another vehicle or leaving campus without office approval.
- Although security personnel are present & will do their best to make sure your car is secure, you park at your own risk. The LDS Church, Desert Vista High School and the Tempe Union High School District will NOT be responsible for damage, theft or loss of property.
- The district/school retains authority to conduct routine patrols of student parking lots and inspections of the exteriors of student vehicles on school property. The interior of student vehicle may be inspected whenever a school authority has reason to believe that illegal or unauthorized materials may be contained inside. Such patrols and inspections may be conducted without notice, without consent and without a search warrant. If a properly conducted vehicle search yields illegal or contraband material(s), such finding shall be turned over to the proper legal authorities for disposition.
- By signing below, the student and parent agree to all items above. Signatures also confirm that the vehicle information provided here is accurate and that all vehicles are currently registered & insured. Forgery will be processed in accordance with school and district policy.
